This individual will be responsible for ensuring care delivery is arranged appropriately within each cluster, ensuring a primary / dedicated team of carers delivers domiciliary care in dedicated clusters, and that these staff members understand and have knowledge of the other community offers and support available to individuals living in these areas. This individual will also be the single point of contact for other agencies to support with multi-agency meetings and approaches for individuals and will attend Managed Network Meetings."

6.
